Processing

1. Heat phase A and B separately to 70 - 75 °C.
2. Add phase A to phase B with stirring1).
3. Homogenize.

4. Cool with gentle stirring and add phase C below 40°C.
5. Add phase D and E.

1) Important: If phase A has to be charged into the vessel first, phase B must be added without stirring.
